A. OSHA Amends the Recordkeeping Regulation

Type: Final Rule

On January 25, 2019, the Occupational Safety and Health Administration (OSHA) amended its recordkeeping regulation by rescinding the requirement for establishments with 250 or more employees to electronically submit information from OSHA forms 300 and 301. These establishments will continue to obtain them as needed through inspections and enforcement actions. In addition to reporting required after severe injuries, establishments will continue to submit information form their Form 300A.

In addition, OSHA is amending the recordkeeping regulation to require covered employers to submit their Employer Identification Number (EIN) electronically along with their injury and illness data submission, which will facilitate use of the data and may help reduce duplicative employer reporting. Nothing in the final rule revokes an employer's duty to maintain OSHA Forms 300 and 301 for OSHA inspection. These actions together will allow OSHA to improve enforcement targeting and compliance assistance, decrease burden on employers, and protect worker privacy and safety.

Effective Date

This final rule becomes effective on February 25, 2019.

B. DOJ/DEA Schedules of Controlled Substances: Placement of MAB-CHMINACA in Schedule I; Final Rule

Area: Drug Enforcement Agency

Type: Final Rule

On January 29, 2019, the Department of Justice, Drug Enforcement Administration (DEA) published a final rule (84 FR 444-448) finalizing the placement of N -(1-amino-3,3-dimethyl-1-oxobutan-2-yl)-1-(cyclohexylmethyl)-1 H -indazole-3-carboxamide (MAB-CHMINACA; ADB-CHMINACA), including its salts, isomers, and salts of isomers whenever the existence of such salts, isomers, and salts of isomers is possible, in schedule I of the Controlled Substance Act.

Effective Date

This final rule became effective on the date of publication, January 29, 2019.
