## A. Interim Environmental Justice and Civil Rights in Permitting Frequently Asked Questions; Interim FAQ

## **Summary**

The Environmental Protection Agency (EPA) has published an Interim FAQ in order to present information regarding Environmental Justice (EJ) and Civil Rights in Permitting. The EPA stated that the main purpose of this FAQ is to present all of the existing information in one place and that this FAQ is not legally binding. This is a "living document" that the EPA intends to update and revise as necessary.

The Interim FAQ document includes a total of 18 questions. The first question presents the purpose of including environmental justice into the permitting process. The EPA's mission is to protect human health and the environment. By including EJ into the permitting process, the EPA can further achieve their mission for all people in the United States.

The document identifies the following three Executive Orders (E.O.) as establishing the federal policy on equity and environmental justice:

- <u>E.O. 12898</u> Federal Actions to Address Environmental Justice in Minority Populations and Low Income Populations (1994)
- E.O. 14008 Tackling the Climate Crisis at Home and Abroad (2021)
- <u>E.O. 13985</u> Advancing Racial Equity and Support for Underserved Communities Through the Federal Government (2021)

The Interim FAQ document continues by explaining the relationship between EJ and civil rights, that they are complementary and have significant overlap. The EPA encourages States and other recipients administering environmental permitting programs to adopt routine processes of screening for EJ and civil rights concerns. The EPA identifies best practices for screening including Geographic Information System (GIS) tools such as EPA's EJScreen, survey questions, looking at other permitted facilities in the area, demographic data, health data as well as other tools and techniques. The EPA explains that if these screening tools identify EJ concerns, actions must be taken to mitigate any adverse disproportionate impacts.

The EPA suggests that a permitting program use the following six steps:

- 1. Screening
- 2. Scoping
- 3. Assessment
- 4. Recommendations
- 5. Reporting
- 6. Monitoring

The EPA Interim FAQ document continues by explaining key concepts and definitions such as Disparate Impacts, Adverse Impacts, Disproportionality, Causation, Justification, Less Discriminatory Alternative, and Cumulative Impacts. The EPA identifies the need to conduct community engagement as well as tribal consultation.

## B. Addition of Diisononyl Phthalate Category; Community Right-to-Know Toxic Chemical Release Reporting; Proposed Rulemaking

### Summary

The Environmental Protection Agency (EPA) has updated the hazard assessment for Diisononyl Phthalate (DINP) and is proposing to add DINP as a category defined to include branched alkyl diesters of 1,2 benzenedicarboxylic acid in which alkyl ester moieties contain a total of nine carbons. This would make these chemicals subject to the reporting requirements under the Emergency Planning and Community Right-to-Know Act (EPCRA) and the Pollution Prevention Act (PPA).

The updated hazard assessment demonstrates that the proposed DINP category meets the EPCRA toxicity criterion because the members of the category can reasonably be anticipated to cause cancer and serious or irreversible chronic health effects in humans. EPA is proposing to add the DINP category to the toxic chemical list on this basis and is requesting comment on the updated DINP hazard assessment and associated updated economic analysis.

Comments for this proposed rulemaking are due on or before October 07, 2022.

### Summary

The Environmental Protection Agency (EPA) is proposing to amend the Risk Management Program (RMP) regulations to change and amplify the accident prevention program requirements. The amendments will also include enhancements to the emergency preparedness requirements, increased public availability of chemical hazard information, and several other changes to certain regulatory definitions or points of clarification. The amendments have a goal to improve chemical process safety, assist in planning, preparedness and responding to RMP-reportable accidents and improve public awareness of chemical hazards at regulated sources.

Some of the key changes to the RMP program include:

- Clarifications specifying that natural hazards, power loss, and proximity to communities should be part of the process hazard analysis (PHA).
- Requiring a Safer Technologies and Alternative Analysis (STAA) as part of the PHA
  for any refinery using hydrofluoric acid (HF) in an alkylation unit and for refineries
  and chemical manufacturers and other facilities in NAICS codes 324 and 325 that
  are within a 1-mile radius of another RMP facility.
- Specifying that a root cause analysis must be performed as part of the incident investigation that follows "RMP-reportable" releases.
- Third-party compliance audits for a facility that has two RMP-reportable accidents within a 5-year period or after any RMP-reportable accident at a refinery or chemical plant that is located within a 1-mile radius of another RMP facility.
- Employee participation relating to the implementation of recommendations from PHAs, incident investigations, and audits; stop-work authority in certain circumstances; and reporting accidents and other RMP non-compliance issues.
- Field training exercises with local responders at least once every 10 years, with the locals able to opt out (current rule does not establish a minimum frequency).
- Requirements around prompt community-wide notifications of RMP-reportable releases.
- More information available to the public, including the recommendations from hazard analysis and code/standard gap analysis that the facility declines to implement and STAA implemented since last PHA.
- Requirement to keep hot work permits for 5 years.
