The project contemplated herein consists of the Contractor replacing the 16-inch "E-tube" section on WESP Vessels #1,3,4,7,9 & 12 as well as sandblasting the interior liner, installing a membrane around the interior base flange and replacing the grout between the base of the vessel and the concrete on WESP Vessels #1,3,4,5,6,7,8,9,10,11&12. All contractor and subcontractor employees shall obtain specific site plant safety training from Veolia Water prior to working on the site. Veolia Water will offer a total of two one-hour training sessions to the contractor and any subcontractors. The Contractor shall adhere to all Veolia Water safety policy and procedures.
